She also recognized Dan Carney and Kristie Williams, assistant vice presidents in Operations and Administrative Services, who were both participating in the REIN Immersion Program; Susan Goldberg, director of examinations in Supervision and Regulation, who was participating in a REIN Talent Share; and staff who were observing the meeting as a development opportunity – Brittany Birken, CED director and principal advisor in Community and Economic Development, and Christina Brennan, senior data analyst in Corporate Engagement Strategy, Risk, and Analytics.

Ms. Arnold announced today's meeting was being recorded to assist with minutes preparation, and following approval of today's minutes, the recording will be destroyed.
