



He also recognized staff who were recently promoted to officer positions: Clint Cary, senior vice president and chief investment officer in the Office of Employee benefits, effective March 4; Alex Monge-Naranjo, vice president and senior economist in the Research division, effective June 1; and Kevin Dancy, vice president and regional executive for Atlanta, effective July 1. He recognized Lali Shaffer, who was participating in a REIN talent share, and staff who were observing the meeting as a development opportunity: Keith Demaray, research support director in Research; Jason O'Rourke, government affairs director in Public Affairs; and Jason Zirpoli, senior vice president and chief technology officer in the Office of Employee Benefits.

Mr. Haile reminded directors that information discussed in this meeting was confidential and privileged and was intended solely for the board of directors of the Bank and its authorized participants.

Mr. Haile announced today's meeting was being recorded to assist with minutes preparation, and following approval of today's minutes, the recording will be destroyed.

ADJOURNMENT


