As I disclosed last year, my husband and I held assets in managed accounts over which we had no discretion. As I now understand, transactions in such accounts are not exempt from the reporting requirements and FOMC blackout period trading restrictions. The transactions that occurred on May 2, 2022, were associated with funds invested through one such account and occurred prior to realizing that they were subject to blackout restrictions. These trades have been reported to the Federal Reserve Bank of Atlanta and Board of Governors ethics officers, as well as reported to the Federal Reserve Inspector General. My husband and I moved all of our assets out of the managed accounts last year.

While preparing my Form A covering calendar year 2022, it came to my attention that a few entries on the Form A covering calendar year 2021 needed to be clarified. These changes are listed in an explanatory statement released June 15, 2023, on AtlantaFed.org.
