



Persistent Child Poverty in Metropolitan and Nonmetropolitan America






Data and Approach


Hispanic Population in Perspective:

Hispanics and foreign-born as a share of US population





Hispanic Population Pyramid (1970 & 2010)



White Population Pyramid (1970 & 2010)




Race-Ethnicity by Metro Area Status (1970)





Race-Ethnicity by Metro Area Status (2010)






Absolute and Percent Change in Child Population by Race/Hispanic Origin, 2000 to 2010








Hispanic Poverty by U.S. Nativity






Rural Poverty Rates by Race-Ethnicity




Urban Poverty Rates by Race-Ethnicity



Suburban Poverty Rates by Race-Ethnicity




Hispanic Poverty Rates by Nativity & Metro Area Status





Brief Summary of Regression Findings

Rural residence less predictive of poverty over time for all and for Hispanics.


Usual suspects (age, gender, education, marital status, children, employment) operated in the expected ways for all and for Hispanics.


OPM VS. SPM

- Implications for Rural America:
 - o OPM is MUCH higher than SPM
 - From 17.9% to 13.9% in 2012
 - o Mhàs
 - Driver=Housing Costs
- Implications for Hispanics:
 - o SPM is higher than OPM
 - o 25.8% to 27.8%
 - o Mhàs
 - Demographics?
 - Safety Net?
 - Immigration?
 - California May Illuminate





The Poverty Reducing Effect of the Social Safety Net in California by Gender, Race-Ethnicity and Educational Attainment



Measurement Implications for Rural Hispanics? (Caution: Preliminary)

- 2011 Poverty Rates
- All Hispanics
 - o OPM* 25.4%
 - o SPM 28.0%
- All in non-Metro places
 - o OPM* 17.0%
 - o SPM 13.4%
- Hispanics in non-Metro Places
 - o OPM* 31.0%
 - o SPM 19.3%
 - Indeed, SPM for rural Hispanics falls between that for all rural residents and all Hispanics





Rural Earned Income Ratios (Age 25-54)




